# 3. Reports

#### President's

Brian Harris presented the President Report 'as read.

To steal a quote from Her Majesty the Queen 2020 has been Dogs NZ's "annus horribilis" a horrible year.

Let us analyse the impact of COVID 19 on our club.

- 2020 National Events including the scheduled FCI shows, National Dog Show, NZDAC and NDOA have been cancelled.
- We will need to rely heavily on local judges if we are to maintain a healthy show schedule during the foreseeable future. Clubs will likely be using only NZ judges well into 2022.
- The impact on our Registry has been limited as the desire to own dogs remained strong and it would appear internationally to have increased. Our office staff have kept the registry operating during lock downs and as a result the financial hit wasn't as great as we anticipated it might be.
- Our staff used lock down to automate the dog registration system.
- The decline in membership has stabilised and we are now focused on automating membership renewals and introducing new member recruitment programmes.
- Executive Council at the request of the Audit and Risk Committee took a worst case approach to a COVD 19 budget for FY20/21.
- This budget was set in April as we entered into level 4 lockdown and forecast was for a (\$489k) deficit after depreciation.
- So far actual results are running ahead of budget expect end of year result to be approx. \$150k deficit.
- The balance sheet remains strong with nil debt and healthy cash reserves which will help us through these difficult times.

The President also noted in particular:

- FY 19/20 Results Dogs NZ posted a small operating profit (\$2k) before depreciation which resulted in a net deficit of (\$93k) which was in-line with budget.
- Capex / Strategy Committees To help guide Dogs NZ into a future of growth and protect our assets the E.C has established two new sub-committees.
- New Sponsor we welcome Nestle Purina as our new naming sponsor.
- Reputation & Relationships Dogs NZ has continued to extend its contacts with outside organisations to strengthen our own organisation. Key initiatives in the past year include:

# Financial Report (year ending 31 March 2020)

Steven Thompson, the Director Secretary presented the Financials Year End Report and COVID Budget in the absence of the Treasurer who was on bereavement leave.

# 1. FY 2019-2020 financial result in-line with budget

- Set a plan and executed that plan. Included much needed expenditure on all three properties Auckland, Wellington & Dunedin. Restored head office staff levels to sustainable level
- Good Outcomes for majority of the National events NDS, NZDAC and YDT annual camp
- ALL committees displayed good governance and worked to achieving their individual plans.
- Modest improvement in revenue for the year

# 2. How are we dealing with the COVID impact on our financial health

- Because of our strong balance sheet (no debt, healthy cash reserves, assets worth multiples of book value) we are well positioned to ride out the financial effects of COVID.
  - o 2019/2020 Balance Sheet table
- Increased cash balances by further \$119k
- Market value of Properties owned by Dogs NZ in the region of \$9.44 million. Completely debt free.
- When COVID hit we reforecast a worst case budget and because it was done at the beginning of L4 lockdown we took a approach
  - o Post / Pre COVID Budget table
- Pre COVID budget reflected \$56k reduction in revenue largely influenced by new Sponsorship model. Expenditure increased \$34k – 1.8% in line with cost of living forecasts.
- Overall a deficit of \$88k before depreciation.
- Post CPVID budget Revenues were dramatically reduced by \$844k a drop of 46%.
   Expenses were reduced to the extent considered achievable and sustainable a reduction of \$539k (28%)

- The result was an overall deficit of \$393k before depreciation. A detrimental impact of \$305k due to COVID disruptions.
- Because Registry & membership income has performed better than forecast and we have performed ahead of the COVID budget
  - o Financial Performance Summary 31 August table
- Revenues did not decrease to the extent forecast over the first 5 months of the current year due to timely renewal of membership. Solid registry activity and strong support from non-member advertising and sponsorship. Non Member users of our facilities have also continued to be supportive.
- Expenditure has been held roughly in line with reduced post COVID budget levels.
- Due to the continued support of our membership our balance sheet remains strong.

- We have even increased our cash position
  - o Cash Flow Statement 31 August 2020 table
- While as we continue to move in and out of regional lock downs we still face revenue challenges and must continue to keep tight control on costs and seizing opportunities when available
- One of the unexpected outcomes of COVID is it has provided staff with the opportunity to focus on Revenue generating improvements such as enhanced on line registration and improved online payment options.
- This work is both increasing revenue and reducing costs (e.g. postage) and delivering better service to members. In addition Creative new ideas have been attempted such as the development of a virtual dog show platform which was used with success by AEC.

# 3. What are our long term Financial Challenges

- We have flat lining revenue trend over the past 8 years and increasing expenditures due to steady inflation of some of our key costs.
- We need to drive registry, membership and dog training revenue with the support of our partners you are going here more about this with the Purina presentation
- We need to deal with the delayed maintenance issues with our facilities so that they remain fit for purpose for dog sports & training and drive additional hire revenue you are going to hear more about this with the Capex Committee presentation
- We need to control costs of our national events
- None of these are "quick fix" issues but we need to be dealing with them now and have a coherent strategy to guide Dogs NZ through the next 10 years.

- Income is insufficient to fund major renovations of aging infrastructure
- Auckland and Dunedin struggle to attract regular large non dog show rental streams

- Site constraints re parking / camping
- Above issues are affecting show enrolments

- Has potential for venue hire revenue growth if
- structural fit out issues resolved
- Substandard office working environment for staff which raises Health & Safety concerns

# Forrester Park Key Issues

- DCC Parks & Reserves restrictions on parking & camping are affecting show attendance
- DCC Parks & Reserve show no interest in resolving the ground issues (uneven surface & chemical leeching from old tip)
- DCC have no interest in reaching any lease agreement which includes the outdoor ring area
- Building improvements are only band ads as the floor is getting worse (due to ground movement) affecting the structural integrity of the building
- Will require substantial investment to resolve
- However any investment in the building will not resolve the first two issues and is seen as pouring good money after bad

#### **Member Consultation Feedback**

- Key questions for all three venues "Is this property fit for purpose & do we stay or do we go"
- Ardmore: Fit for purpose, clubs wish to preserve facility for dog sports in upper North Is. Has major long term land value appreciation potential
- Wellington: Fit for purpose if upgraded, clubs wish to preserve facility for dog sports in lower North Is. Land value will continue to appreciate due to regional development
- Forrester Park: No longer fit for purpose & due to continued restrictions on dog events, clubs do not want to stay.

#### Motion

Rule 15 (e) (II) have the words "New Zealand Kennel Club Obedience Committee" be deleted and replaced with the wording "New Zealand Kennel Club Dog Training Committee".

Likewise, Rule 20 (d) (i) (3) have the words "New Zealand Obedience Committee" be deleted and replaced with the wording "New Zealand Dog Training Committee".

#### Rationale

Such a change will enable the current NZKC Dog Obedience Committee to be renamed as the NZKC Dog Training Committee which better reflects the diversity of codes embraced and administered by the NZKC Dog Obedience Committee. There appears to be considerable perception by those not involved in one of the current Obedience codes that the NZKC Dog Obedience Committee deals only with those involved in competitive Obedience. Even among those involved in current Obedience codes, there is some lack of understanding that they are administered by the NZKC Obedience Committee. At present, the Dog Obedience Committee oversees five quite diverse codes, and there is the prospect of this increasing. A change to the title of Dog Training Committee better reflects the diversity and functioning of this committee and provides a better perception of their role.

# Recommendation 1 – Kumeu Kennel Association

19.16 Disqualifications (Current)

19.16.1 A dog which is not shown in all classes in which it is entered or eligible to compete by virtue of prior awards will be disqualified from winning any prize or award at the show. A dog will not be deemed absent from a class until the class has been assembled and is about to be passed over by the Judges Steward for the judge to commence judging. At this stage any disqualification can be made, and the elevation of a lower placed dog will take effect.

#### Recommend:

19.16.1.1 (New Para)

Notwithstanding the provisions of para 19.16.1 a dog that has been awarded a Challenge Certificate may be withdrawn from further competition without the challenge certificate being withdrawn once the breed judging has been concluded.

#### Rationale:

Under the current regulations a challenge winning dog must continue to be shown until that dog has been beaten in competition. If the challenge winner did not compete at the group level or if that dog was beaten in the breed but still received the challenge and the BOB won the group and they did not compete, under our current regulations, the challenge would be forfeited.

This amendment would enable the exhibitor to determine at which point they withdraw their dog from competition, after BOB judging has been completed. It would also remove the requirement for RBOB challenge winners to remain for the group judging. By winning the Challenge certificate the judge has determined that it is of sufficient merit for this award and in their opinion is the best example of that sex in the breed.

At this point it has been evaluated as being worthy of this award over all of the other competitors. No dog would be penalised if it was withdrawn from competition at this point. In today's show world we have many shows where due to the need to have back to back shows many shows have very late finishing times.

This regulation change will simply allow the dogs owners to determine if they wish to remain and compete at the Group level and not forfeit their awarded challenge if they choose to not compete. If a young dog is being shown and the owners determine it is unlikely to win at the group stage, they can elect not to show, and the Challenge certificate award would be preserved.

This change would then allow the exhibitor the flexibility to determine at what point they wished to exit the competition without penalty of losing their challenge.

# 10. Discussion Paper (1)

The President announced the voting strength for recommendations - 67.

The President invited the Director Secretary to present the Social Media Policy & Dispute Resolution discussion paper.

# Background

In November 2019 meeting Executive Council asked the Director Secretary to develop the following detailed amendments to the Social Media Conduct and Discipline & Settlement of Disputes Regulations to provide "greater teeth" to our enforcement of the Social Media Code of Conduct.

In June 2020 the Director Secretary presented a number of recommendations to Executive Council to update and strengthen the current enforcement of the Social Media Code of

Conduct. The Executive Council discussed the proposals and agreed they are not prepared in the current climate of membership disputes to make a decision on strengthening the Social Media Code of Conduct with recommended changes to the Disputes Regulations.

Executive Council requested that the Director Secretary prepare a discussion paper for member feedback via Dog World submissions before ACOD where it will be presented for a decision by delegates.

## **Discussion Paper**

The handling of social media complaints and disputes places a considerable cost in time and money on the National Office. We would on average receive 2-3 complaints per week about member's behaviour on social media. Dealing with these complaints is equivalent to one full office staff work day per week.

If the social media dispute becomes a formal complaint then the time and resources devoted by Dogs NZ to resolve the issue increases dramatically. Any formal complaint will include the following procedure:

- Director Secretary receives Complaint
- Dogs NZ President determines if prima facie case for further investigation
- Chair of Disputes Committee either makes a ruling on the complaint or calls for a full hearing of the complaint.
- Full Hearing by Disputes Committee
- Written decision back to Director Secretary with recommendation to EC
- Any decision/penalties ratified by EC communicated back to both parties by Director Secretary
- Parties have 28 day right of appeal on decision to EC Judicial Review Committee
- Any Appeal is reviewed by Judicial Review Committee
- Judicial Review Committee final ruling to parties

Dogs NZ members have a choice regarding social media behaviour and disputes.

- We can either decide that policing social media is not a core business of Dogs NZ and that any disputes regarding social media behaviour between members is best resolved in the civil courts.
- Or we can decide that there should be a minimum code of behaviour for Dogs NZ members on Social Media and it should be enforceable by our Disputes Regulations.

If it is the view of members that policing social media is not any business of Dogs NZ then we will with draw the Social Media Code of Conduct and only take steps under of Disputes Regulations to protect staff from harassment or abuse.

If members still wish to have a minimum code of behaviour for Dogs NZ members on Social Media then we need to be prepared to make the following proposed changes to our Social Media Code of Conduct and Disputes Regulations.

# **Proposal One**

 Proposal that we adopt the changes outline in the attached Dogs NZ Social Media Code of Conduct document which further define what is social media and what constitutes acceptable / unacceptable behaviour.

• Proposed Changes to the Disputes Regulations

# 2. Grounds for complaints

- (a) A complaint may be laid against any member or society who:
- (X) Is in breach of the NZKC/Dogs NZ Social Media Code of Conduct

### 3. Laying a complaint

- (c) Complaints must be in writing and set out
- (ix) Contain an actual copy of the post (i.e. screen shot) if it relates to a breach of the Social Media Code of Conduct.

#### 9. Penalties

- (a) The penalties that may be imposed under these Regulations include all or any of the following:
- (xv) If found in breach of Social Media Code of Conduct the imposition of a fine of \$200 may be fixed, payable to the New Zealand Kennel Club.

# **Proposal Three**

• Proposal that we do not adopt the Dogs Queensland policy of an exemption clause in the payment of compliant fees for Social Media complaints, due to the volume of complaints we receive for member behaviour on social media.
