4. Matters Arising from previous Minutes:

Raised by LC – The recent regulation submitted to EC should be added to our previous minutes for Endorsement KM Advised these changes were advised the Regulation changes were Endorsed by the post Judges Conference meeting held at Ardmore on the 17th March at which there was a quorum – the March 20th meeting also had these circulated for any further discussion.

Raised by LC – The Judges Probationary Assessment form needs to have Mentor added, KM advised it has been done and has requested it be added to our Webpage. Was sent to Matt Levens to upload

Raised by LC – Off Line searches. Noted that AvdB statement that AKC (American Kennel Club) do not have this option is incorrect – AKC do have an off line search option. For further discussion with incoming committee.

Raised by LC – New Judges & Judges promoted need to go up on Website – KM has done a comprehensive review & submitted to DNZ regarding amendments to our Judges panel – still has not been actioned. KM will submit again.

7. Regulations

<u>Rewards 10.7.3</u> – Following feedback from SW & Judging community and further discussion within the committee the following urgent amendment will be submitted to EC for Email Vote to ensure the new Regulations for 1st July read as follows:

10.7.3 A handler is permitted to use food or a toy to reset/refocus their dog on one occasion only, in addition to Regulation 10.7.1, in the scent area on one occasion only without incurring any penalties. Subsequent resets/refocusing will however incur penalties use of food or a toy will incur penalties.

AP: KM will email this to Fiona to request EC Email vote to ensure Regulation is amended for 1st July Publication

<u>Timing 9.6 –</u> Alert Call multiple hides – feedback from Jo Miller – problem may occur if Timer cannot see the full search area and when a handler calls again on same hide location – Timer likely to stop timing but handler can proceed to find correct hide. Further discussion by Committee. Regulation remains unchanged but would advise Judges to instruct their Timers what they want if the above scenario arises.

8. General Business

a) Qualifying Scent Work Trials – Nil received

LC raised concern that CKA / Invercargill have a SWT on same weekend on August 24th & 25^{th,} especially given that Invercargill has had this date each year.

Concerns amonst committee that Calendar not fully updated – would help avoid clashes.

Jo Miller – Excellent Containers – Endorsed

LC – proposed that Jo Miller be consider under the Core Group of Judges or be promoted under Exceptional Circumstances Regulation to all Excellent Panels.

Rationale: There are only two Judges currently in the South Island that are at Excellent & Masters Panel level. With the Introduction of the full Masters classes options to contract enough higher level judges are limited needing to contract more northern Judges and with more trials northern Judges are getting busier/less availability.

Those on the committee who have conducted Probationary assessments for Jo in the past, fully endorse this recommendation, pending Jo completing the full Excellent Panel Exam.
